### **Felton Discovery Park**

Parks now has contract with landscape contractor and biologist to maintain and monitor mitigation areas for the Library and Park, and the contractor has replaced plants for 2020 and biotic monitoring report has been submitted to CA Fish and Wildlife.

<u>Chanticleer Park</u>: Staff is working on application for Prop 68 Statewide Park Program grant application for Phase 2.

### **Heart of Soquel Phase 2 & 3**

Construction of the new trail and restoration landscaping is underway and the site preparation, utilities, pathway, piers and the boardwalk and viewing platforms carpentry, planting and irrigation, most lighting and some fencing have been completed.

### **Hidden Beach**

Parks Department Planning staff continue to review proposals from play structure manufacturer representatives to replace the existing play structure. The Parks Department has entered into a contract with a consultant to prepare a conceptual plan, produce 30% design drawings, and host one public meeting, likely to be held in Spring 2021, for the siting and design of the new permanent restroom.

### **Moran Lake**

The Coastal Conservancy has informed the Parks Dept that staff is recommending award of the planning grant for the Moran Lake Restoration Plan for Water Quality Improvements to the Coastal Conservancy Board in March 2021. The planning grant scope includes detailing water quality improvements (e.g., native plant installations, creation of bioswales, and trail improvements), completing the state environmental review, and developing materials for development permit submission.

### **Greyhound Rock**

Parks Department staff continues to work with the state Coastal Conservancy and state Department of Fish and Wildlife staff on the grant application for planning and development of minimalist overnight accommodations and indoor programming facilities at the park.

### **Live Oak Library Annex**

Parks Department staff is participating on the Technical Advisory Group with County Department of Public Works and Library staff as well as an architectural firm to produce interior and exterior design plans for the Live Oak Library Annex, proposed for construction along the north wall of the Simpkins Family Swim Center. The TAC is currently incorporating historical references of the Live Oak community into the draft designs. A Planning staff intern is completing a timeline of local events to be including in the interior design.

#### Farm Future Phase 2

Park Department Planning Staff and Consultants are working on preparing a Master Plan Amendment Application to include a bike pump/jump track as an additional alternative feature and revise the development permit expiration date. The MPAA will be submitted to the County Planning for review and consideration. Planning staff is finalizing a grant application for the Statewide Park Program for funding to complete implementation of Phase 2.

## Seacliff Village Park Phase 2

Installation of the new permanent restroom building is complete including mural painting and Parks maintenance staff have added additional landscape enhancements around the building.

- Throughout the County, various Learning and Enrichment Camp sites have been up and running since the start of the school year.

## **Reservations during COVID:**

- Staff is continuing to book for limited park use, outdoor wedding ceremonies, small picnic gatherings, and outdoor fitness classes. Athletic fields were in use for limited activities by youth sports through November 15<sup>th</sup> at which time the sports fields closed for the fall//winter season.
- Through the months of October, November and December, Reservations has booked 3
  outdoor ceremonies, 6 fitness groups, 2 small picnic gatherings and 1 Nursing
  Graduation drive-through hosted by Heath Services Agency. We continue to respond to
  multiple inquires for the allowed booking options.
- The garden plots at Chanticleer Park are being filled from the waitlist that was started when the parks master plan was introduced.
- The two empty horse stalls at Quail Hollow Ranch will be filled from current waitlist in the beginning of 2021.
- Parks staff co-sponsored wedding ceremony days with the County Clerk's office in the
  months of August, September, and October at Aptos Park, Highlands Park and Quail
  Hollow Ranch, which saw 22 couples wed in total. Parks is looking at continuing the
  ceremony day events with Clerks Office in the future months.
- We continue to actively keep in touch with future reservations as the Health Order gets modified through the phases of re-opening.
- We continue to work on new policies for the public for future and current rentals during COVID.


### **Felton Discovery Park**

## **ROLE OF THE COMMISSION**

For the benefit of the citizens of the County of Santa Cruz, the Arts Commission is responsible for advising and making recommendations to the Board of Supervisors and the Parks Department staff on all matters relating to the encouragement and coordination of artistic and cultural affairs within the County. In addition, the Commission:

- 1. Identifies and addresses the unmet needs of cultural and artistic life in Santa Cruz County.
- 2. Serves as advocates for the arts, soliciting multiple sources to support artistic and cultural programs in Santa Cruz County.
- 3. Communicates and cooperates with the County of Santa Cruz, Department of Parks, Open Space and Cultural Services and related Commissions, community and private resources and arts-related groups performing as contractors, in order to ensure coordination of arts and cultural activities.
- 4. Assembles and makes available to the public up-to-date information relating to Santa Cruz County's artistic and cultural resources.
- 5. Is responsible for Arts Council oversight for the Board of Supervisors and conducts an annual review in June.
- 6. Helps facilitate public and private partnerships for the Arts in Santa Cruz County.

## **MEETINGS AND STRUCTURE**

The Arts Commission meets no more than six times each fiscal year, with meeting dates to be determined by the Commission based on program needs. Meetings are generally held at 4:30 p.m. at the Parks administrative office.

The Arts Commission is made up of ten members, two nominated by each Supervisor, which operates using the Sturgis Rules of Order and a structure that includes a Chairperson and a Vice-Chairperson. Staff support is provided by the Department of Parks, Open Space and Cultural Services.
